
Objectives

Procedure for grievance redressal

1. Students have to approach internal examination in- charge.
2. An application duly stating the grievances to be submitted to the examination department.
3. Having gone through the application, the exam department will forward it to the principal.
4. The principal in consultation with the concerned faculty will examine it in detail, make a remark on the application before sending it back to the examination department.
5. After taking necessary steps of students.
6. The process is completely transparent.

If the issue remains unresolved, you can approach the head of the department or the convener of the examination cell.


Fill out the grievance form available with the department or examination cell and submit it to the designated officer.
